New Business:

1. **Introduction of SCC Members.** The current School Community Council Members roster was passed around for all members to check their email addresses and phone numbers. This is was will be posted on our school website. Dates of upcoming meeting were also discussed and presented to the current council.
2. **Election of Chair (by parent group) and Co-Chair.** Jeanell Sealy was voted as the Chair of the 2015-2016 School Community Council. Jenni Frost mad the motion with Alicia Christensen seconding the motion. The vote was unanimous. Alicia Christensen volunteered to take meeting notes. As a school we would like to increase this to an A. Mrs. Wilson shared that she has been meeting with the district testing specialist as well as teachers to work towards improvement. We are analyzing the data to see if we need to increase our proficiency rate, growth rate, or both. Mrs. Seely asked if there is information that we can share with parents regarding the importance of testing. Also if there are things parents can work on at home. This will continue to be an ongoing discussion. When will parent's get scores?
7. Other. The SCC had a discussion regarding "Bullying". As a school we need to clarify the difference between Bullying and mean kids. Parents discussed they would like a yearly assembly. Mrs. Anderson had a committee working on this for the year. We will discuss how this is going at our next meeting. Teachers shared that they have this discussion with students on a regular basis.
